1. General characteristics

The lead-free solder alloy Sn96,5Ag3Cu0,5 is manufactured by Cynel-Unipress in the first smelting of tin, silver and copper. Its chemical composition complies with ISO 9453:2014. The use of a continuous casting process ensures that the metal oxide formation in the solder alloy is minimized. As a result, the negative effect of the formation of dross in the soldering process has been significantly reduced. The product is designed for a wide range of industrial applications in electronics and electrical engineering where RoHS compliance is required. It can be sold on the consumer market and also used by private individuals outside professional applications.

3. EVO11 flux

Halide, medium-active, rosin based flux. Unique set of activators used in EVO11 flux provides very good wettability on various metal surfaces (especially copper and brass) except for aluminum and its alloys. EVO11 flux is not "No Clean" class flux. Flux residues can be removed with isopropanol based cleaners. Decision to wash off flux residues should be undertaken by the user.
